OHPC intends to recruit bright, qualified and energetic professionals to be inducted as **MANAGEMENT TRAINEES (MTs) & DIPLOMA ENGINEER TRAINEES (DETs)** in various disciplines as follows for their placement at various units & project sites.

During the training period MTs/ DETs shall be paid the above consolidated stipend plus medical allowances at the fix rate of Rs.200/- per month and an additional amount of Rs.1000/- per month shall be paid to the trainees posted at BHEP, Balimela and UIHEP, Mukhiguda as Remote Area Allowance. After successful completion of training, they will be paid Basic Pay, DA, HRA & other allowances as admissible under OHPC Rules in force from time to time.

(C) TRAINING

The training will be for a period of 1(One) year, unless and otherwise extended. On successful completion of the training, the candidates will be appointed in the respective cadre on probation for a period of One year and on regular scale of pay with other allowances as mentioned at SI-B. The services of trainees may be terminated during the training period without any notice or assigning any reasons thereof. There shall be no obligation on the part of the Corporation to offer regular appointment after completion of training.

(D) SERVICE AGREEMENT BOND

The selected MT/ DET candidates shall be required to execute a service agreement bond on Non-judicial stamp paper to serve the Corporation for a minimum period of 3 years (including the training period) at the time of joining. The Bond amount for MTs & DETs will be as follows:

(F) <u>AGE</u>

- i. For DETs, a candidate must not be under 18 (Eighteen) years and not above 32 (Thirty Two) years of age as on 01.08.2025.
- ii. For MTs, a candidate must not be under 21 (Twenty One) years and not above the age 32 (Thirty Two) years as on 01.08.2025.
- iii. The Upper age limit prescribed above relaxable by 05 (Five) years for candidates belonging to SC/ ST/ SEBC/ Women/ **Ex-Serviceman** and by 10 (ten) years for PWDs whose permanent disability is 40% or more.
- iv. Persons with disabilities (PWD) belonging to SC/ST/ SEBC categories are eligible for cumulative age relaxation benefit upto 15 years.
- v. Provided that a person who comes under more than one category mentioned above, shall be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him / her.
- vi. The date of birth entered in the High School Certificate Examination or equivalent Certificate issued by the concerned Board / Council will only be accepted.

(G) RESERVATION

- i. Reservation of posts including reservation for Women will be as per the ORV and other applicable Acts and Rules of Government of Odisha.
- ii. PWD Candidates, whose disability is not less than 40% (forty percent), are required to attach Disability Certificate indicating percentage of disability & type of disability issued by the concerned Medical Board for consideration as per Rules.
- iii. Ex-Servicemen are required to attach their copy of Discharge Certificate issued by the Competent Authority. Concession meant for **SC & ST by birth** are admissible to the Scheduled Castes and Scheduled Tribes of **Odisha State only**.
- iv. Concession meant for **SEBC** are admissible to the Socially and Educationally Backward Classes of **Odisha State only**.
- v. The competent authorities to issue the caste certificate are District Magistrate / Collector or Additional District Magistrate or Sub-divisional Magistrate / Sub-collectors or Executive Magistrate or Revenue Officers, not below the rank of Tahasildar / Additional Tahasildar of Government of Odisha.
- vi. Candidates belonging to PWD & Ex-Serviceman shall be adjusted against the categories to which they belong.
- vii. In the event of non-availability or insufficient number of eligible / suitable women candidates belonging to any particular category, the vacancies or the remaining vacancies shall be filled up by male candidates of the same category.
- viii. Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered.
- ix. Candidates belonging to SEBC category shall submit their SEBC certificate validated / renewed by the competent authority within the last 3 (three) years by the closing date of submission of online application form. The SEBC certificate which is more than three years old by the closing date of submission of online application form is liable for rejection.
- x. OBC Certificates will not be accepted in lieu of SEBC Certificate and candidates submitting OBC certificate are liable for rejection.
- xi. Women candidates belonging to SC and ST are required to submit Caste Certificate by birth showing "daughter of ". Caste Certificate obtained by virtue of marriage (i.e. showing "wife of ") are not acceptable & liable for rejection.
- xii. Community (Caste status) once mentioned by the candidates in the online application form, will be treated as final and the same shall not be changed under any circumstances.

iii. The PWD certificate is subject to verification of the candidate by the prescribed Medical Board.

(I) OTHER ELIGIBILITY CONDITIONS

- (i) The candidates must be citizen of India.
- (ii) He / She must be able to read, write and speak Odia fluently, and must have
 - a. Passed Middle School Examination with Odia as a language subject, or
 - Passed HSC or equivalent Examination with Odia as medium of examination in nonlanguage subject, or
 - c. Passed in Odia as a language subject in the final examination of class-VII from a school or educational institution recognized by the Government of Odisha or the Central Government or
 - d. Passed a test in Odia in Middle English School Standard conducted by the School and Mass Education Department of the Govt. of Odisha
- (iii) A candidate who has more than one spouse living or in case of a woman candidate, if married to a person having one spouse living, shall not be eligible for appearing the examination, unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons.
- (iv) The candidates must have a good moral character.
- (v) Candidates, who fulfil the prescribed eligibility criteria on the effective date may apply for the post.

(J) SELECTION PROCEDURE

i. Eligible candidates will be called for Computer Based Test Comprising 120 Multiple Choice Questions (MCQs) divided in two parts i.e. Part-I: 40 questions from General Aptitude- Quantitative Aptitude, Reasoning, English, General Awareness etc. & Part-

II: 80 questions from subject knowledge in the respective discipline. The candidates shall secure 01 mark for each correct answer & there will be negative marking of 0.25 marks for each wrong answer. The duration of the CBT will be 02 hours. The question papers will be in English language only.

- ii. Candidates qualifying in the written test (CBT) shall be shortlisted for Document verification at Bhubaneswar.
- iii. The merit list will be drawn purely on the basis of performance in the CBT only.
- iv. The offer of appointment shall be issued to the selected candidates on the basis of merit. However the final appointment of selected candidates will be subject to their medical fitness as per the prescribed standard & verification of prescribed testimonials.
- v. On selection they shall be posted at any of the Units / Project sites & Offices of OHPC & its subsidiaries.

(K) CENTRE OF EXAMINATION

- i. The Computer Based Test (CBT) will be held at Bhubaneswar/ Cuttack/ Rourkela/ Sambalpur/ Berhampur/ Balasore/ Angul/ Jeypore/ Bhawanipatna. However depending on the number of applicants, OHPC may add or limit other cities of Odisha.
- ii. Candidates are required to mention their preferred centre of examination in the online application form.
- iii. The request for change of centre shall not be entertained.

(L) APPLICATION FEE (NON-REFUNDABLE) AND MODE OF PAYMENT

i. UR, SEBC candidates are required to pay a non-refundable fee of Rs. 750 /- (Rupees Seven Hundred Fifty) only while filling up online application. Candidates belonging to Scheduled Caste (SC) / Scheduled Tribe (ST) of Odisha only & PWD candidates are exempted from application fee.

ii. For on-line payment mode through Debit / Credit Card / Net Banking,etc:

In case of On-line payment mode, an applicant will be redirected to payment gateway page under Tech Process. After completing the On-line payment, she / he must take hard copy of the payment Receipt. She / He must retain the hard copy and proof of payment for future reference / record which shall be required at the time of verification of original certificates / testimonials as and when necessary. The candidate shall bear the online transaction charges as applicable.

(M) GENERAL INFORMATION & INSTRUCTION

i. At present, only the online applications are invited from the candidates for admission to the Computer Based Test. After declaration of CBT result the candidates who will be shortlisted in the CBT will be required to furnish a printout / hard copy of online application form along with photo copies of

- certificate and documents on or before prescribed date for document verification, which will be intimated on OHPC website on a later date.
- ii. Degree certificate, Caste Certificate, Odia Test Pass Certificate, Discharge Certificate of Ex-servicemen and Identity Card of physically Handicapped . Persons must have been issued by the competent authority within the last date fixed for submission of online application form.
- iii. A candidate found guilty of seeking support for his / her candidature by offering illegal gratification or canvasing in any form or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/ herself liable to criminal prosecution, be disqualified not only for the ongoing recruitment, but also may be debarred permanently from any recruitment or selection to be conducted by OHPC.
- iv. Application submitted to OHPC if found to be incomplete in any respect are liable for rejection. No correspondence shall be entertained in this regard.
- v. Mere applying for the post and fulfilled eligibility criteria in reference to the advertisement does not confer any right for an applicant to claim appointment.
- vi. Any dispute arising out of the ongoing recruitment shall be subject to jurisdiction of High Court of Orissa.
- vii. Candidates working in State / Central Government / PSUs / Autonomous Bodies of Govt. shall apply online. However, he/she must produce a No Objection Certificate (NOC) at the time of document verification.
- viii. The candidates must possess sound health & good physique and free from any physical deformities to discharge of his/ her duties in the service except PWD candidates. Candidates selected under PWD category must be within the prescribed normal range for all other physical standard. The PWD candidates will have to undergo a verification process by the authorized medical Board on the date specified failing which his candidature will be forfeited. Final selection of the candidates shall be subject to medical examination at our designated hospitals. Candidates fail to pass the medical examination will not be considered for appointment.
- ix. While applying for the above post, the applicant shall ensure that he/she fulfils the eligibility and other norms mentioned above, as on the specified dates and the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment / selection that a candidate does not fulfil the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact (s), his/her candidature will automatically stand cancelled. If any of the above shortcoming (s) is / are detected even after appointment, his/her services are liable to be terminated without any notice.
